New Business

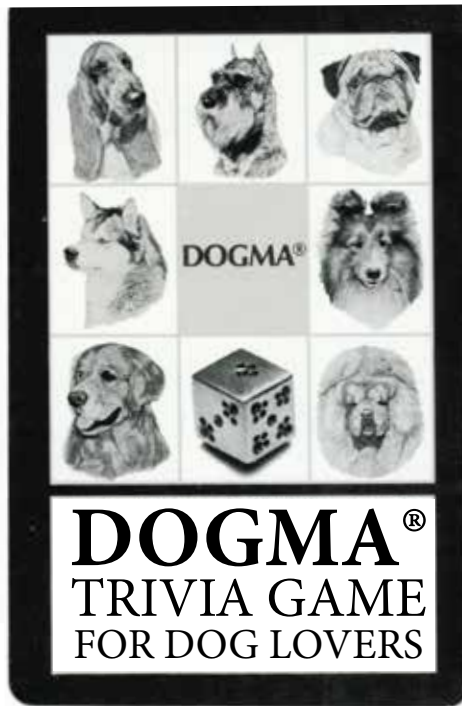
