All dogs hold a special place in our hearts, and it's always hard to lose them. Jasper may not have been the greatest dog that ever lived, but he had a life that I think is worthy of noting. So for him and for me, I am writing this— his obituary.

I don't know all the details of his early life, but I know that he was adopted out of a shelter in central Nebraska. For some reason it didn't work out and he was returned to the shelter. He was then adopted by Noah's Assistance dogs to train as a seizure alert dog.

He first lived in Lexington with a trainer named Tedi. I got him to train shortly after- he was about 1 1/2 years old.

He excelled in his training, loved to visit Walmart. He would "bump" the Life cereal because he knew that's what I always bought. He could pick up a credit card off a tile floor, among many other tasks.

He was placed with a little boy who was having seizures and he did a great job alerting to the seizures, but he became overly protective of his boy, so he was returned to Noah's and was placed with a gentleman. This man later had an operation that cured his seizures, so Jasper was once again returned to Noah's. By this time he was getting close to being too old to place as a service dog, so we adopted him as our dog.

I started showing Jasper in Rally and Obedience. He earned many titles in both, as well as trick tiles and his barn hunt instinct. In all his time showing, he only had one NQ, at his first show. At the time of his death he also had 5 of 10 legs in Rally Masters, and one of three legs in Barn Hunt Novice.



He loved to travel, and visited Kansas, Wyoming, Colorado, South Dakota, Kansas and Missouri, as well as many camping trips in Nebraska. He lived to go hiking and exploring, and went for a walk almost every day up until about 10 days before he died. In June of 2020 he was diagnosed with bone cancer and had to have his left front leg amputated. The cancer claimed his life on April 16, 2021.
